International Training on Social Entrepreneurship in Guiding and Scouting

WHY WORK WITH SOCIAL ENTREPRENEURSHIP

Duty to Others is one of the fundamental principles in Girl Guiding and Girl Scouting. The training on social entrepreneurship in guiding and scouting will focus on putting Duty to Others in a new perspective by aiming at creating sustainable value in the local community. The training combines the Girl Guide and Girl Scout method with the "Design for Change" methodology for working with social entrepreneurship with youth and children.

The aim of the training is to get experience on working with social entrepreneurship in a Girl Guiding and Girl Scouting context for creating value adding community projects with a strong focus on involvement and empowerment of guides and scouts. When empowering the guides and scouts in the creative and decision making process they experience a great sense of ownership for the value creation.



PARTICIPANTS WILL

- Learn about the "Design for Change" approach to working with social entrepreneurship with youth and children
- Get to know participants from all different Guiding and Scouting organisations in Europe including the Danish Guides and Scouts
- Create own plan for implementing social entrepreneurship and value based community projects in Girl Guiding and Girl Scouting



TARGET GROUP

- You are working with either programme or training in your association and are in a position where you are able to work implementing learnings from the training in your association
- Additionally, we encourage the participation of young leaders below 30 years of age

To insure diversity amongst the training participants we encourage you to send maximum two participants pr. guiding and scouting association.

The training will be held in English, thus a certain level of English proficiency is needed to fully benefit from the training.

In order to meet different learning styles and needs, a variety of methods will be used, such as: presentations, visits, case studies, discussions, brainstorming and reflection groups.

PARTICIPANT FEE

Participation fee and accommodation will be covered by the Joint Committee of Girl Guides in Denmark.

Participants will have to pay for their airfare to and from Billund Airport, while the bus trip to and from Holstebro is a part of the training and therefore covered.

DATES

The training will take place from the 1st-4th of December 2016.

The training starts on Thursday the 1st of December at 13.00 at Billund Airport. Participants are therefore encouraged to arrive Thursday the 1st of December in the morning. If you need to arrive Wednesday the 30th of November we can help arrange accommodation at a convenient location, but you need to cover this by yourself.

The training ends on Sunday the 4th of December at 14:30 in Billund Airport. Flights out should be booked no earlier than 17:00. Participants are of course also welcome to stay longer and explore

Denmark on their own. Copenhagen can be reached by train or domestic flights.

VENUE AND ACCOMMODATION

The first part of the programme takes place in Billund. Thereafter participants will go by bus to Holstebro, which takes approximately 1 hour. The main venue in Holstebro is Danhostel (Sysselting 2, 7500 Holstebro) for both the training and accommodation. But we will also visit different locations in Holstebro as part of the training.



INSURANCE

The Joint Committee of Girl Guides in Denmark does not cover insurance of participants during the event neither during the travel to nor from the venue. Please note that this is exclusively the responsibility of participants to check, whether they are covered by their association or need to take out a private travel insurance (covering illness, accidents, repatriation etc.).
